What Information Do We Collect?

Information You Provide:

- **Account Registration:** Contact information, such as name, company name, address, email address, and phone number, provided during account registration.
- **Communications:** Additional information provided when you contact us, including message contents and attachments.

Information We Collect Automatically:

- **Cookies and Tracking:** Data such as IP address, geo-location, browser type, operating system, and interaction with our Services.
- **Usage Data:** Information about how you use features of our Services, including frequency of visits and functionality usage.

Information From Third Parties:

- **Third-Party Accounts:** Data from accounts linked to our Services, such as authentication tokens.
- **Third-Party Partners:** Publicly available information combined with existing data about you.

How Do We Use Information?

We use the collected information to:

- Provide, operate, and maintain our Services.
- Improve and personalize user experience.
- Develop new products and features.
- Communicate with users, including updates, marketing, and promotional purposes.
- Ensure compliance with legal obligations.

How Do We Share Information?

We may share information with:

1. Vendors and Service Providers:

- **Supabase:** Primary database and authentication service managing user data, team information, and application state.
- **OpenAI:** Provides natural language processing for comment analysis, response generation, and moderation. OpenAI retains data for 30 days for operational purposes unless a zero-retention policy is activated.
- **PostHog:** User analytics, event tracking, and feature usage monitoring.
- **Google Tag Manager:** Tracks events, conversions, and marketing analytics.
- **Resend:** Manages transactional emails, including notifications and team invitations.
- **Paddle:** Handles payment processing, subscriptions, and invoicing.

2. Social Media Integrations:

- **Facebook & Instagram:** Page management, account connections, and webhook subscriptions for updates.

3. Infrastructure Providers:

- **Hetzner:** Hosts application servers in the EU.
- **Vercel:** Hosts the frontend application and handles serverless functions globally.

4. Aggregate Information: Shared in de-identified forms.

5. Business Transfers: Shared during mergers, acquisitions, or similar transactions.

6. Legal Requirements: Disclosed to comply with laws, regulations, or governmental requests.

7. With Consent: Shared with your explicit permission.

How Do We Protect Information?

- **Data Security:** Measures include encryption, secure storage, and restricted access.
- **Payment Information:** Processed securely by Paddle; we do not store credit card details.
